STRATEGIC PRIORITIES

Gender equality and equity

- Place gender as a **fundamental issue that cuts across all aspects** of habitat-related rights.
- Strengthen **women's leadership** at all levels to influence public policies
- Strive to eliminate all forms of **legal discrimination** against women

Fight against violations of all rights related to habitat

- Denounce all **violations** of rights related to habitat
- Act against **territorial expulsions and land grabbing**; fight against gentrification and for the upgrading and regularization of popular settlements.
- Support organizations and movements that fight against the negative effects of **globalization and the capitalist system** (social and territorial effects of megaprojects, privatization of public services, commodification of social housing)

Right to a healthy environment

- Place environmental protection as a fundamental issue that **cuts across** all aspects of habitat rights.
- Support the collection and dissemination of research on the **impacts of climate change** faced by the most vulnerable populations.

Social Production of Habitat

Social production of habitat

Latin America: between 50% and 75% of housing and habitat components are self produced by inhabitants, without adequate instruments (legal, administrative, financial, technical, etc) to support such an effort.

Within HIC we refer to these experiences as **social production of habitat** and we are convinced that the **formative, organizational, productive and management processes** they involve, as well as the **social and economic resources they mobilize and activate**, have a high transformative potential.

For many years we have been working to **influence public policies and to open institutional experiences that broaden the scale and social impact of this type of practices**. So much so that different legislations in the region recognize this type of production.

Positive results in different countries and contexts, and the richness of some experiences, encourage us today to **deepen our knowledge, exchange experiences, disseminate results and articulate efforts** at the regional level to promote their development. That is why in 2014 we formed the regional working group on social production of habitat.

STRATEGIC PRIORITIES

Social Production of Habitat

- **Self-management** of habitat through cooperatives and grassroots organizations. Promote self-production and mutual assistance to build alternatives
- Alternative to **neoliberal policies** such as the commodification of territory, land and housing
- Fight against the **criminalization of inhabitants** living in vulnerable situations

FOSTERING ALTERNATIVES FOR AFFORDABLE HOUSING



Social production of habitat

1. Self organization of those excluded and marginalized
1. Support in the mobilization of resources, technical support that articulates socioeconomic, cultural and environmental aspects
1. Bottom-up, collective diagnosis
1. Use of local materials and traditional techniques, offsetting environmental impact and increasing resilience
1. Self construction, collective or with outside support, can include structural improvements in the neighboring areas


